Dear Dr. Wiberg:

Enclosed please find Abbott Laboratories' amended report identifying all payments, honoraria, reimbursement and other compensation, totaling \$100 or more, paid to licensed practitioners in Minnesota during calendar year 2006 in connection with its businesses that market prescription drugs. The Abbott Laboratories' report was amended to also include payments made to 4 Minnesota practitioners by Kos Pharmaceuticals, which was recently acquired by Abbott. The practitioners associated with these payments are the last 4 practitioners listed on the report.

Although Minnesota law identifies these reports as public data, Abbott considers the information contained in this report to be confidential, proprietary, and/or commercially sensitive. Abbott does not publicly release this information, in individual or aggregate form. Release of this information would undermine Abbott's relationships with its contractors and consultants and allow competitors to gain a business advantage.
