In connection with this submission, please note that per a communication to you dated April 24, 2006, effective on or about March 31, 2006, Daiichi Pharmaceutical Corporation (“DPC”) was merged with and into Sankyo Pharma, Inc. (“SPI”). Sankyo Pharma, Inc. then changed its name to Daiichi Sankyo, Inc. (“DSI”). The address remains unchanged (Two Hilton Court, Parsippany, NJ 07054). 
