In accordance with Minnesota Statute §151.47(f), Millennium Pharmaceuticals, Inc. submits the enclosed report of payments made in calendar year 2006 to health care practitioners. The payments contained within this report are excluded from the definition of "gifts" under Minnesota Statute §151.461, and are therefore authorized payments.

The enclosed report is based on Millennium's good faith understanding of the statute. Pursuant to Minnesota Statute §151.47(f), this report contains information only with respect to payments made to individual health care practitioners. Please note that Millennium provides funding to health care institutions, including hospitals and academic institutions, for the conduct of clinical research. Those institutions, in turn, make payments to individual health care practitioners as compensation for their research activities. We have not included these payments in the report because that funding has been provided to the institution where the research is being conducted and not to an individual health care practitioner.

Similarly, Millennium provides financial support for a broad range of medical education programs that benefit health care practitioners, and this funding is also not captured within the report. These payments are not made to individual health care practitioners but to the institutions and other accredited providers of the educational activities. In order to maintain the independence of these educational programs and to meet the guidelines of the Accreditation Council for Continuing Medical Education (ACCME), Millennium does not track the names of the individual health care practitioners who benefit from these programs.

Please note that Millennium considers the information contained in this report to be its proprietary and trade secret information, the disclosure of which may cause irreparable harm to Millennium. For this reason, we respectfully request that we be contacted in advance if this information is to be disclosed by the Minnesota Board of Pharmacy and given the opportunity to provide a redacted version of the report appropriate for public disclosure.
