Enclosed please find our report identifying payments to prescribers during calendar year 2006 in accordance with Minnesota Statutes § 151.47(1)(f). The enclosed report reflects all payments made to prescribers in Minnesota by Pfizer Inc and includes all of Pfizer Inc's Wholesale Distribution Centers registered with the Minnesota Board of Pharmacy (the "Board").

Pfizer takes its obligations to comply with reporting laws very seriously. As noted in my letter of March 29, 2007, Pfizer has endeavored to analyze the accuracy of the report for 2005, which it filed on that date. This analysis has revealed, in part, that Pfizer significantly over-reported its expenditures for 2005. Because the payment data available in Pfizer's systems did not permit a ready identification of whether or not the payee was a licensed prescriber in Minnesota, Pfizer included payments to some individuals who it has learned were not, in fact, prescribers licensed in Minnesota; indeed, many were not even healthcare professionals. This over-inclusion of individuals artificially inflated the total reportable expenditures in Pfizer's 2005 report. In accordance with the obligations Pfizer agreed to undertake on March 29, Pfizer intends to refine its 2005 report and file a new, more accurate 2005 report on or before August 1, 2007.

Thank you in advance for your patience with Pfizer's compliance with its reporting obligations to the Board. As we have indicated previously, Pfizer has invested in excess of \$5 million to help improve its ability to comply with the reporting requirements in Minnesota and other states.
