Pursuant to Minn. Stat. Ann. § 151.47(f), enclosed please find the Shire LLC (“Shire”) report of payments, honoraria, reimbursements and other compensation paid to practitioners in Minnesota during the calendar year 2006.

Shire is aware that it has not made this filing in the past. Shire has made substantial progress in the last year in developing processes by which this information can be captured and submitted with greater accuracy than would have been possible in prior years. A number of efforts have been undertaken to assure that Shire will be in full compliance going forward with the Minnesota and various state reporting obligations that exist and are pending throughout the United States. Dedicated compliance staff has been added and systems revamped and improved. Shire has additionally undergone significant reorganization, has many new employees, and relocated its principal US Commercial and R&D headquarters in late 2004/early 2005 to Wayne, PA from Kentucky and Maryland respectively. To attempt to reconstruct payment activities for 2005 and before is not something that can be done with any guarantee of completeness, given the moves, the lack of searchable records, the change of personnel and the passage of time. I assure you, however, that compliance with this requirement will not be an issue in the future.
