Pursuant to Minnesota Statutes §151.461, (3) – (5) and §151.47, subd. 1(f), enclosed please find the above-referenced completed report for Daiichi Sankyo, Inc. (“DSI”).

Please note that DSI was formerly known as Sankyo Pharma Inc (“Sankyo”) and, as was previously disclosed to you in our 2006 Report, reflects a merger of Sankyo Pharma Inc. and Daiichi Pharmaceutical Corporation on or about March 31, 2006. Please update your records accordingly if you have not already done so.

This report covers any reportable activity for DSI for the period from January 1, 2007 through and including December 31, 2007.

DSI is respectfully requesting that the information contained in this submission be protected from public disclosure pursuant to Minnesota Statutes Chapter 13 (the “Law”) as nonpublic data and private data on individuals. The enclosed information supplied by DSI is, among other items protected from disclosure by the Law, a compilation of data maintained by DSI as confidential, i.e., “secret,” and from which DSI derives or potentially derives economic value from the compilation not being generally available to others. As such, the elements of a nonpublic “trade secret” set forth in Minnesota Statutes §13.27 are satisfied.
