To whom it may concern:

In accordance with Minnesota Statute §151.47(f), Millennium Pharmaceuticals, Inc. submits the enclosed report of payments made in calendar year 2007 to health care practitioners. The payments contained within this report are excluded from the definition of “gifts” under Minnesota Statute §151.461. The enclosed report is based on Millennium’s good faith interpretation of the applicable statute.

Pursuant to Minnesota Statute §151.47(f), this report contains information only with respect to payments made to individual health care practitioners. Please note that Millennium provides funding to health care institutions, including hospitals and academic institutions, for the purpose of clinical research. Those institutions, in turn, may make payments to individual health care practitioners as compensation for their research activities. Since that funding has been provided by Millennium to the institution where the research is being conducted and not to an individual health care practitioner, such payments are not included in this report.

Similarly, Millennium provides financial support for a broad range of medical education programs designed to benefit health care practitioners. This funding is not captured in the report as these payments are not made to individual health care practitioners. Rather, such payments are made to institutions and other accredited providers of the educational activities. In order to maintain the independence of these educational programs and to meet the guidelines of the Accreditation Council for Continuing Medical Education (ACCME), Millennium does not request and/or track the names of the individual health care practitioners who benefit from these programs.

Millennium considers the information contained in this report to be proprietary and trade secret information, the disclosure of which may cause irreparable harm to Millennium. For this reason, we respectfully request that the Board of Pharmacy contact Millennium in advance if this information is being disclosed.
