Enclosed please find Pfizer Inc's (Pfizer) report identifying payments to prescribers during calendar year 2007 in accordance with Minnesota Statutes § 151.47(1)(f). The enclosed report reflects Pfizer's good faith effort to disclose all payments made to prescribers in Minnesota by Pfizer Inc pursuant to § 151.461(3) to (5) of the statute.

Pfizer sponsors a variety of research conducted by outside healthcare providers to support its drug development initiatives. To ensure compliance with various laws and industry standards, all forms of research activities, including those related to clinical trials, must have genuine scientific value, include only investigators selected on the basis of criteria relevant to the research effort, and involve compensation consistent with the value of the research actually provided. Pfizer contracts with full service contract research organizations (CRO) to manage study sites and investigators. In these cases, Pfizer makes the clinical trial payments to the CRO, which then pays the investigator or institution per agreement between the CRO and investigator / institution. Thus, payments for clinical research services to CROs are not included in this report. In addition, the report does not include payments to a sponsor of a medical conference, professional meeting, or other educational program, since such grants are not provided directly to a practitioner, but rather to an independent 3<sup>rd</sup> party entity.

As we have indicated previously, Pfizer continues to improve its state reporting business processes and systems and takes its obligations to comply with reporting laws very seriously. Pfizer shall supplement this report should additional information become available.
