Pursuant to applicable Minnesota state law, SmithKline Beecham Corporation d/b/a GlaxoSmithKline ("GSK") submits to the Minnesota Board of Pharmacy GSK's 2008 report of its payments, reimbursements or other compensation paid to individual practitioners. The attached report reflects payments made by GSK to Minnesota practitioners for consulting services and services provided in connection with educational programs. I affirm that to the best of my knowledge the information contained in this report is true, correct and complete.

GSK has arrangements with foundations, universities, contract research organizations and other business entities to conduct research or provide information under which payments may be made by such institutions to Minnesota practitioners. Compensation to Minnesota practitioners in these cases is not from GSK; therefore, payments to these entities are not reflected on the attached report. Similarly, the report does not state payments to sponsors of independent medical conferences, continuing medical education programs, professional meetings or other educational programs, where GSK may provide funds through a grant to an organization, but does not pay a practitioner (e.g., educational grants).

Although the Minnesota law states that the reports are public data, GSK considers the information in this report to be confidential and proprietary information. GSK does not publicly release this information or the company documents that were used to create this report. Further, release of the entries in this report or the aggregate information in this report may give GSK's competitors information that may undermine its relationship with its contractors and consultants and enable competitors to gain a business advantage.
